Purpose

At the ERO Officials meeting with Minister Tinetti on 7 September, the Minister requested further information and comments on what other jurisdictions are reporting about the impact of COVID-19 on education of indigenous learners and communities. This work was undertaken by Te Tāhu Whare, ERO's Māori medium Evaluation, Research and Review team.

Summary of international research: The impact of COVID-19 on the education of indigenous children and communities

- 2. The purpose of this summary is to provide a snapshot of the impact COVID-19 has had on the education of indigenous children and their communities in different parts of the world. This work draws on countries with vast populations, mainly India, Mexico, Canada, Hawaii, and Australia.
- 3. This summary is based on several research publications and articles sourced from the world-wide web. Most research findings are informed by quantitative and qualitative data. UNESCO and UNICEF publications have been major sources of information but are not the only source.
