ERO Education Evaluation Centre Work Programme: Possible New Projects

Purpose

1. This briefing updates you on ERO's planned national research and evaluation work programme and publications (in English-Medium) for 2023, and seeks your views on possible new projects.

Background

- 2. ERO's research and evaluation is focused on providing insights that change teaching practice, ensure system settings are right, and raise education outcomes.
- 3. ERO has strengthened its evaluation and research programme through the creation of Te Ihuwaka | Education Evaluation Centre and Te Pou Mataaho | Evaluation and Research Māori. Across these areas there is a multi-year, multi-method evaluation and research programme.
- 4. This briefing sets out the existing work programme of Te Ihuwaka and possible new projects. A briefing on the work programme of Te Pou Mataaho will follow.

Existing work programme

- 5. We set our work programme to align with the Government's Education Work Programme, meet the needs of teachers and leaders, and focus on the areas where we can make the biggest difference.
- 6. The Te Ihuwaka | Education Evaluation Centre work programme aims to provide insights into education through:
 - i. Understanding the system performance - on different aspects and for different groups of learners.
 - Evaluating initiatives to build our understanding of what works. ii.
 - Promoting good practice to increase the use of evidence in practice.
- 7... Recent publications have included reports on education for learners from ethnic communities, best practice in working with Teacher Aides, and two in depth reports on

the drivers of attendance. We have an ambitious work programme already underway for 2023 under five workstreams:

- i. Education system performance
- ii. Priority groups
- iii. Key aspects of education
- iv. Evaluating initiatives
- v. Shining a light on good practice

Possible new projects

10. In identifying priorities for the work programme going forward, we have drawn on the perspectives of other education agencies, key sector bodies, trends emerging in data and evidence, and on our regional and national intelligence about what is happening on the ground. We have identified the following possible projects, in the table below.

Skills for the future	Responding to increasing discussion internationally about global competencies by looking at what the global competencies are that our learners will need to thrive in the future (e.g., media literacy, global citizenship, multi-lingualism). How well are we preparing learners for this future?
Priority groups	
The lost children	Building on our work on attendance, alternative education, and Te Kura - looking at who the children not in school are, what education they are accessing, how they end up out of education, and what we can do to reconnect them with education.
Manging challenging behaviour	Responding to increased concerns about behaviour after Covid- 19, how schools manage challenging behaviours and what practices are most effective - including the impact of stand- downs and exclusions, and what the evidence shows are more effective practices.
Learners' mental health	Building on our work on counselling in primary schools looking at what the learners' mental health issues in school are and what the most effective practices and programmes schools can put in place are.

Think forward	Following changes to careers advice, how well does careers advice and subject selection support learners to find the education pathways they need to achieve the careers they want? What practices work well? What could be improved?
Skills that work	Building on looking at subject selection, how strong are our vocational pathways for learners in schools? Are they accessible and coordinated, and do they provide skills that enable learners to succeed in work?
Our new teachers	Building on our work on new principals, how well are new teachers prepared and supported to succeed in the first years of teaching? How do they progress?
Use of AI in education	This fast-moving area is a focus of many countries - what are the emerging opportunities and risks that AI poses for education and what are emerging best practices?

Improving early language and literacy skills	Looking in ECE, how can we improve early language and literacy skills? This responds to concerns about the impact of Covid-19 disruptions on oral language development.
After streaming	What are evidence-based approaches for supporting students that are achieving significantly lower than their peers? How have teachers and schools implemented these approaches?

Increasing impact

- We continue to trial new ways to increase the impact of our findings through how we disseminate evidence to teachers and leaders in schools and services. This includes new digital methods, use of social media, tailored forums and webinars, and producing new ranges of more accessible products. We have had increasing uptake, engagement, and positive feedback from the sector in respect of these initiatives.
- 12. As we take this work forward, we will continue to partner with other education agencies, experts, and researchers to ensure that all our research is complementary and draws on other agencies' and jurisdictions' data and expertise. In particular we are:
 - Joining the international Evidence in Education Network that the UK's Education Endowment Fund runs. This will provide us with access to the emerging thinking on effective practices and expertise on mobilising evidence.
 - Working closely with the Australian Education Research Organisation (AERO) to ii. share methods, expertise, and link up on related projects.
