## 2 ERO's Judgements

<u>Akarangi | Quality Evaluations</u> evaluate the extent to which early childhood services have the learning and organisational conditions to support equitable and excellent outcomes for all learners. <u>Te Ara Poutama</u> <u>Indicators of quality for early childhood education: what matters most</u> and <u>Early Childhood Education (ECE)</u> <u>Improvement Framework (teacher led services)</u> are the basis for making judgements about the quality of the service in achieving equity and excellence for all learners. Evaluations for improvement | Ngā Aronga Whai Hua is integrated across all of the above domains.

# 3 About the Service

Kid's Cove Infants and Toddlers Albany is one of three services under the same ownership. A qualified regional manager, centre manager and three room leaders provide leadership to the teaching team. The Kid's Cove philosophy values the uniqueness of each child, their interests and their connection to family and community.

#### 4 Progress since the previous ERO report

ERO's 2021 ERO Akanuku | Assurance Review report showed that all identified areas of non-compliance were addressed by the service in response to ERO's findings. Leaders and teachers have worked to maintain compliance with regulatory requirements.

## 5 Learning Conditions

#### The learner and their learning | He Whāriki Motuhake

The service's curriculum reflects aspects of *Te Whāriki*, the early childhood curriculum, and is beginning to better reflect the service's priorities for children's learning.

- Children learn through nurturing, trusting relationships with their teachers. Children's social competence, self-help skills and independence are fostered.
- Children experience a curriculum based on activities and their interests. Teachers are becoming more collaborative and intentional in how they respond to and extend children's learning.
- Assessment for learning records identify individual children's interests, milestones and preferred learning styles. While teachers make links to the valued learning outcomes of *Te Whāriki*, they are yet to use this information to evaluate children's progress over time.

# Collaborative professional learning and development builds knowledge and capability | Whakangungu Ngaio

A range of processes enable teachers and leaders to continue to build their professional knowledge and expertise.

- Leaders and teachers inquire into their own practice and its influence on children's learning. Serious reflection from teachers enables changes to teaching that responds to those children with additional learning needs.
- Leaders and teachers attend a range of professional learning and development events to build their knowledge and expertise. The difference this is making to professional practice and children's learning is not consistently evident.
- A professional growth cycle process is in place to build teachers' understanding and capabilities in their role. Leaders generally affirm teachers' practices but are yet to consistently provide feedback to teachers that critically examines teaching practice to support improvement.

# 6 Organisational conditions

#### Leadership fosters collaboration and improvement | Kaihautū

Leaders work collaboratively to enact the service's vision, plans and priorities for improvement.

- Leaders allocate time and resources for teachers to engage in ongoing communication with each other. There is a shared understanding of expectations and tasks across the teaching team.
- Internal evaluation processes enable increased focus on aspects of the programme. Changes in teaching and some children's outcomes are noted, however evaluation of how well teaching is impacting on specific groups of children is yet to occur.
- Leaders and teachers work collaboratively with external agencies and the wider learning community to grow their knowledge and progress priorities.

#### Stewardship through effective governance and management | Te Whakaruruhau

The organisation uses a range of information to develop and refine their strategic priorities.

- Those responsible for governance self-assess where they are at and revisit their strategic plan regularly to focus on ongoing improvement. Leaders are yet to look at how these actions are impacting on children's outcomes, to support decision making.
- Long-serving leaders refine and implement policies, procedures and practices that support induction of new staff.
- A sufficient adult: child ratio promotes the service's ongoing focus on children's learning and wellbeing.

# 7 Management Assurance on Legal Requirements

Before the review, the staff and management of Kids Cove Infant and Toddlers Albany completed an *ERO Assurance Statement and Self-Audit Checklist*. In these documents they attested that they have taken all reasonable steps to meet their legal obligations related to:

- curriculum
- premises and facilities
- health and safety practices
- governance, management and administration.

During the review, ERO looked at the service's system for managing the following areas that have a potentially high impact on children's health and safety:

- emotional safety (including positive guidance and child protection)
- physical safety (including supervision; sleep procedures; accidents; medication; excursion policies and procedures)
- suitable staffing (safety checking of staff, ratios)
- relevant evacuation procedures and practices.

All early childhood services are required to promote children's health and safety and to regularly review their compliance with legal requirements.

### 8 Where to next for improvement?

Kids Cove Infant and Toddlers Albany will include the following actions in its quality improvement planning:

- Improve teachers' shared understanding of the theories of teaching and learning that underpin *Te Whāriki* and how these can be used to extend children's learning.
- Increase the extent to which the learning outcomes from *Te Whāriki* are used to show what matters most for each child and to consistently record their progress over time.
- Strengthen leaders and teachers collective understanding of effective evaluation, to increase the focus on how well systems, practices and changes to teaching improve outcomes for children.

Activities undertaken by the evaluation team

- Pre-visit contact with the service provider/manager.
- Reading documentation and records of children's learning and development.
- Scanning the learning environment and resources.
- Observations of interactions and teaching practice while onsite.
- Meetings and / or conversations with leaders and teachers.
- Sampling of information related to compliance.
